



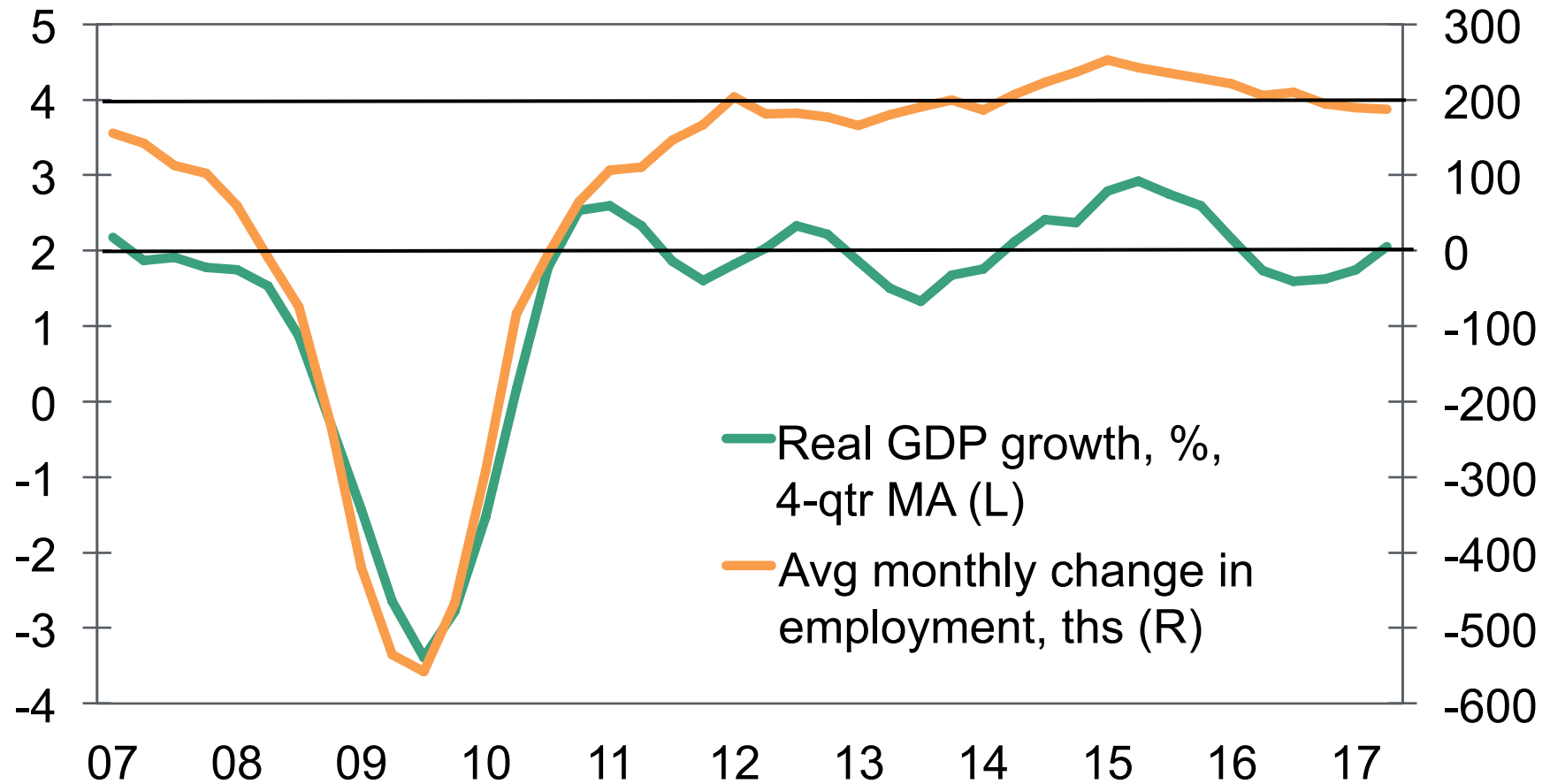

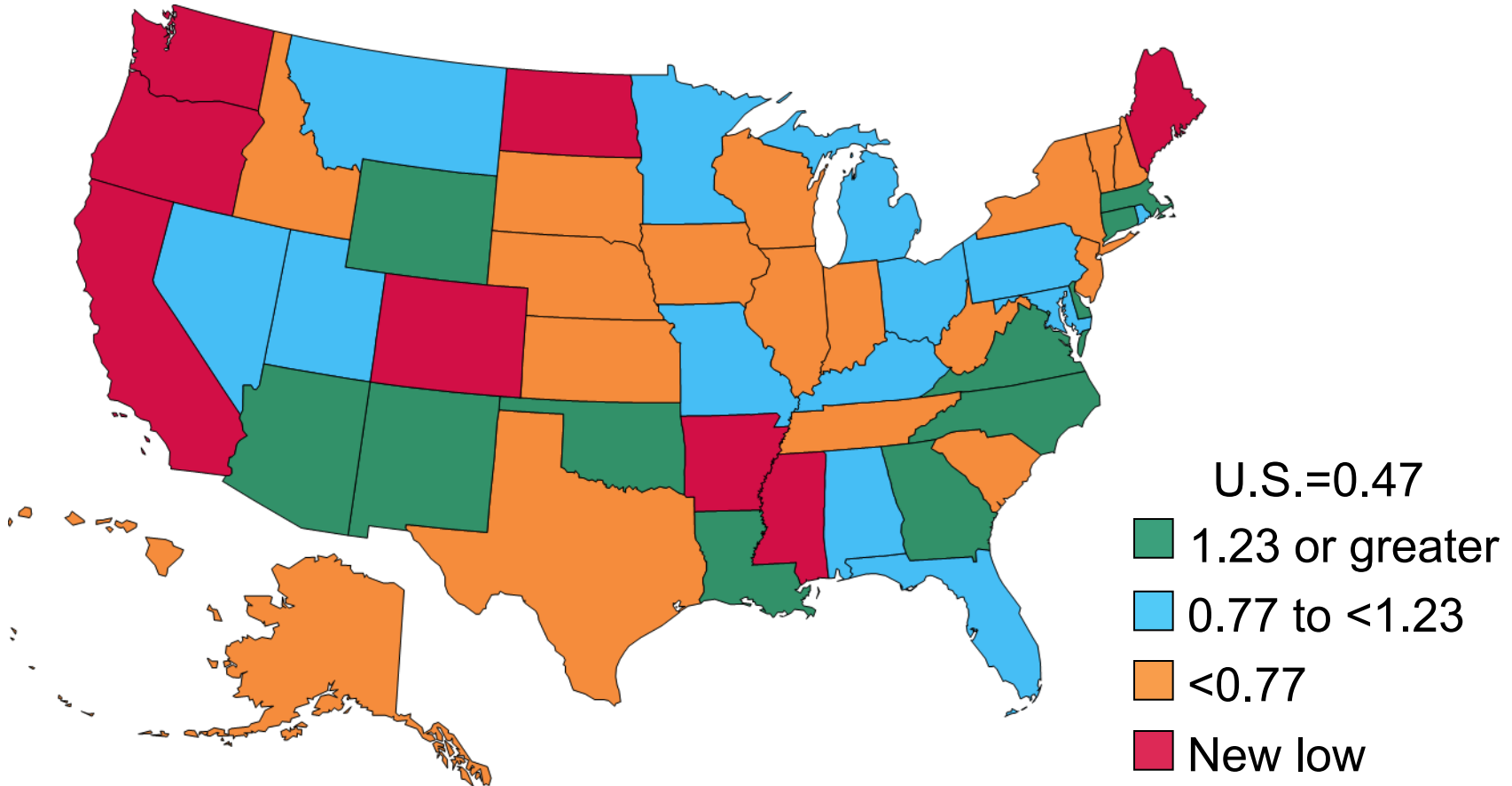

Regional Pattern More Nuanced

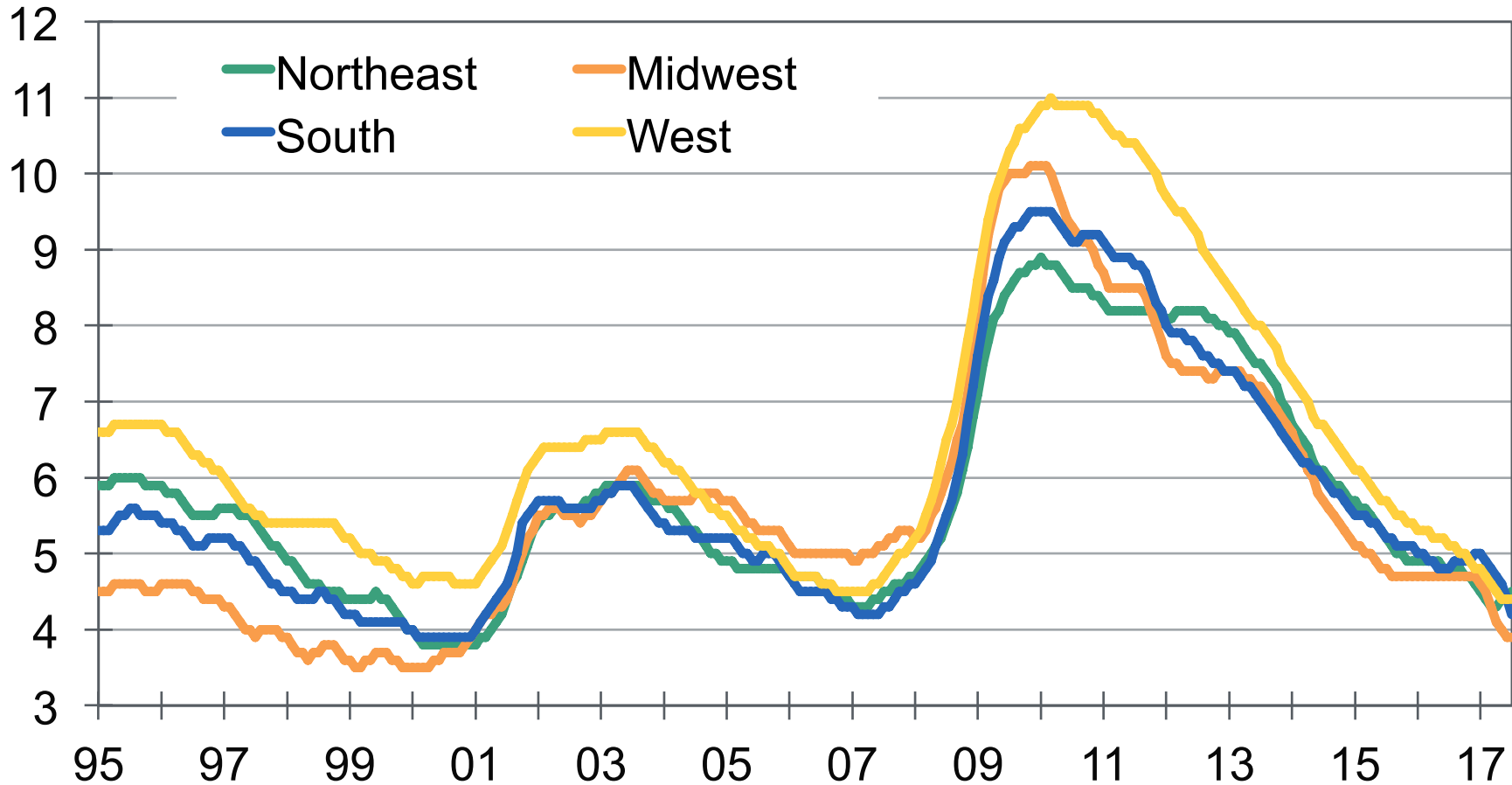
Unemployment rate, 2017Q2, diff. from low of last cycle, ppts

Midwest's Jobless Rate Cracks 4%

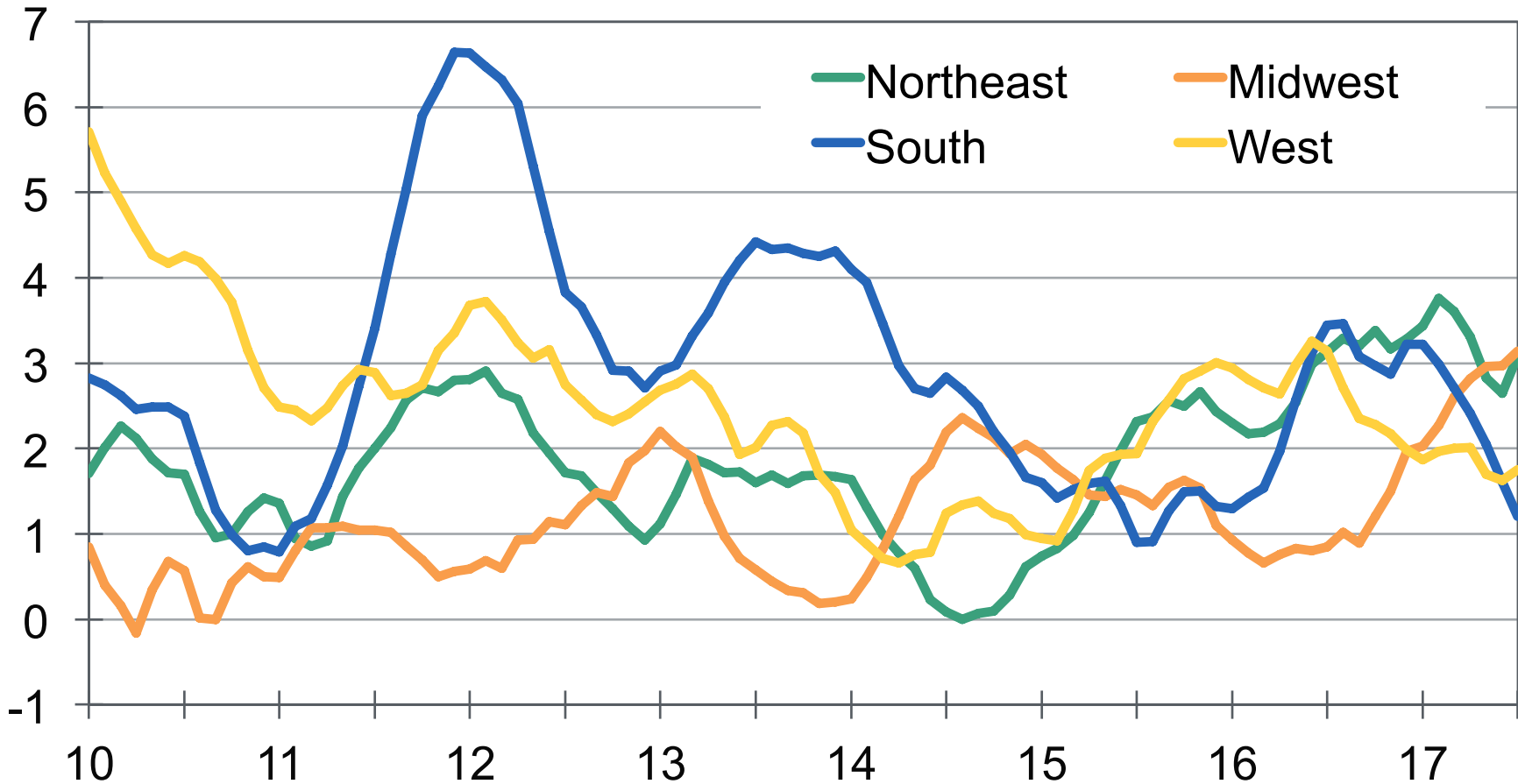

Wage Pressures Rising in Northeast & Midwest

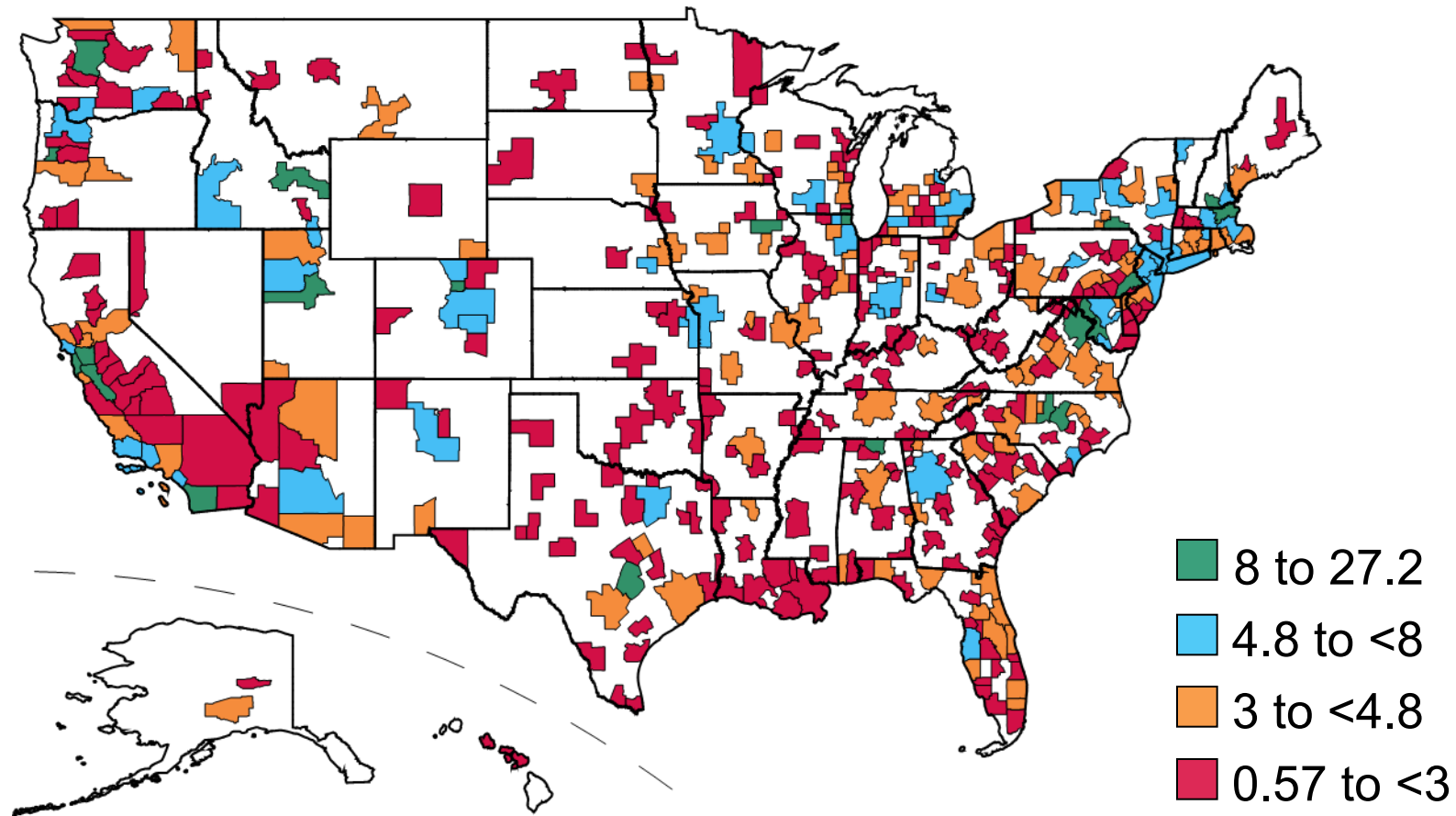
Avg hourly earnings, manufacturing, % change yr ago

Tech Jobs Correlate Well With Wage Pressure

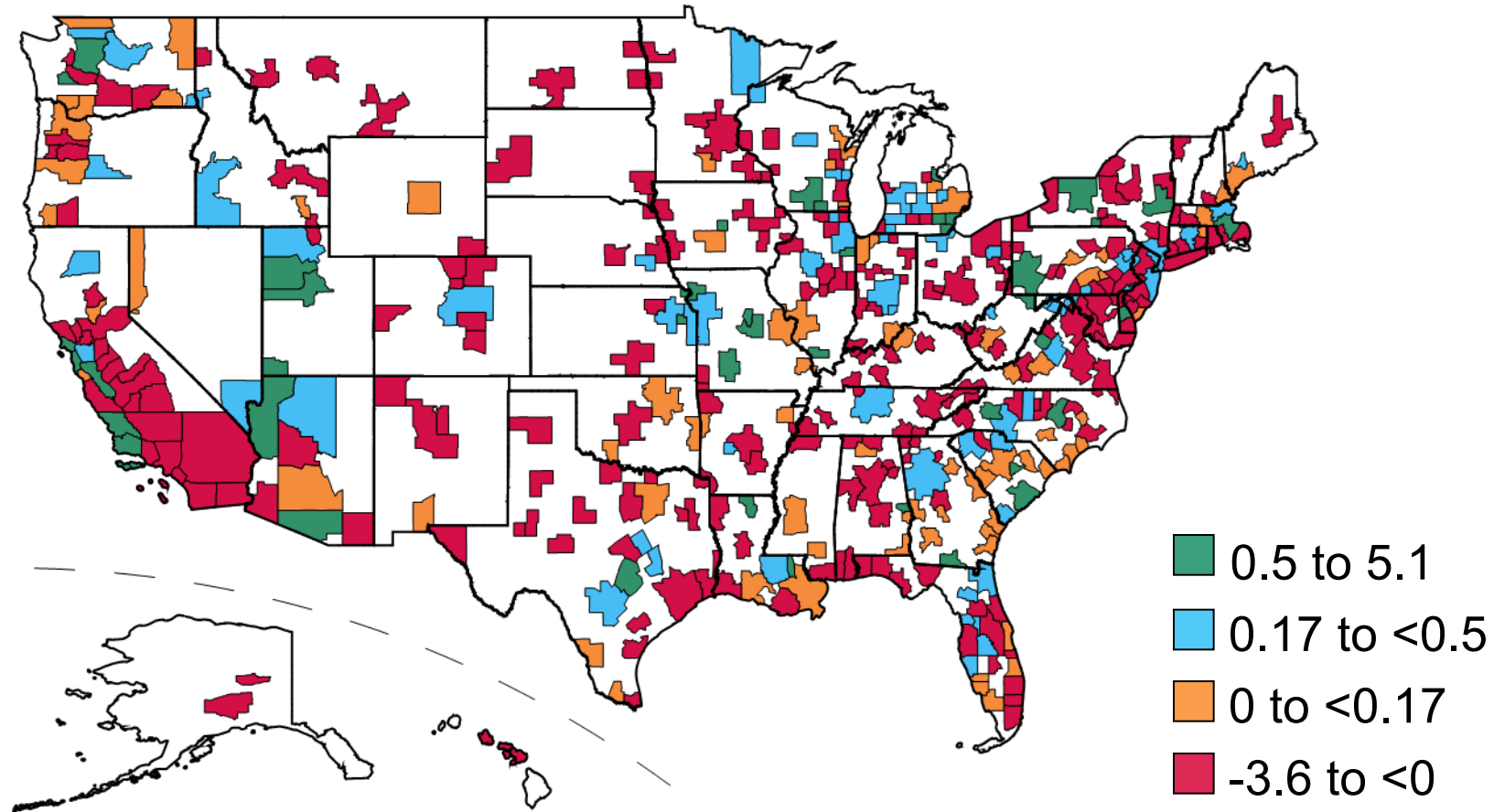
High-tech jobs, % share of total employment, 2016

Tech Concentrations Becoming More Widespread

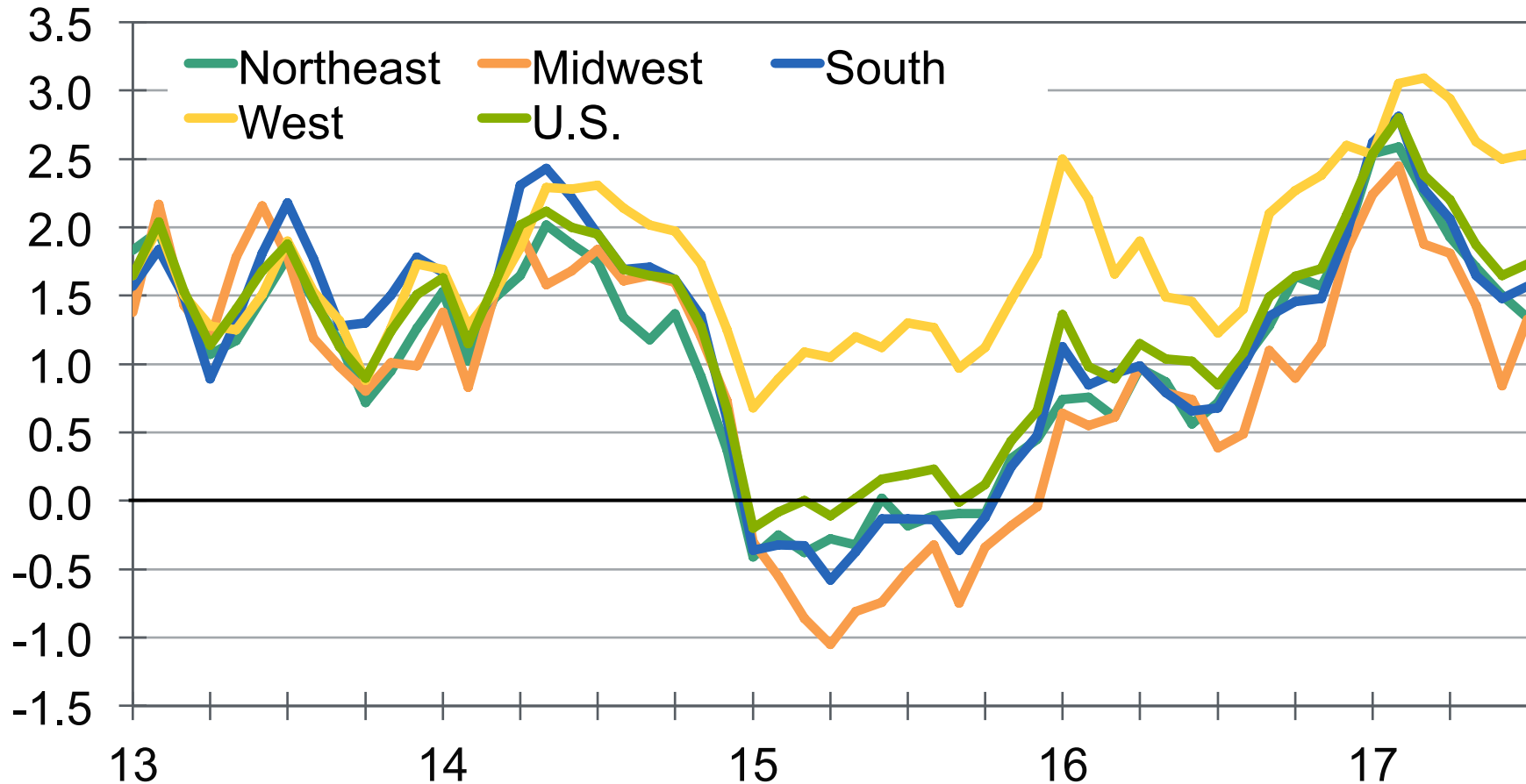
High-tech jobs, % share of total, change 2010-2016, ppts

Highest Inflation in the West

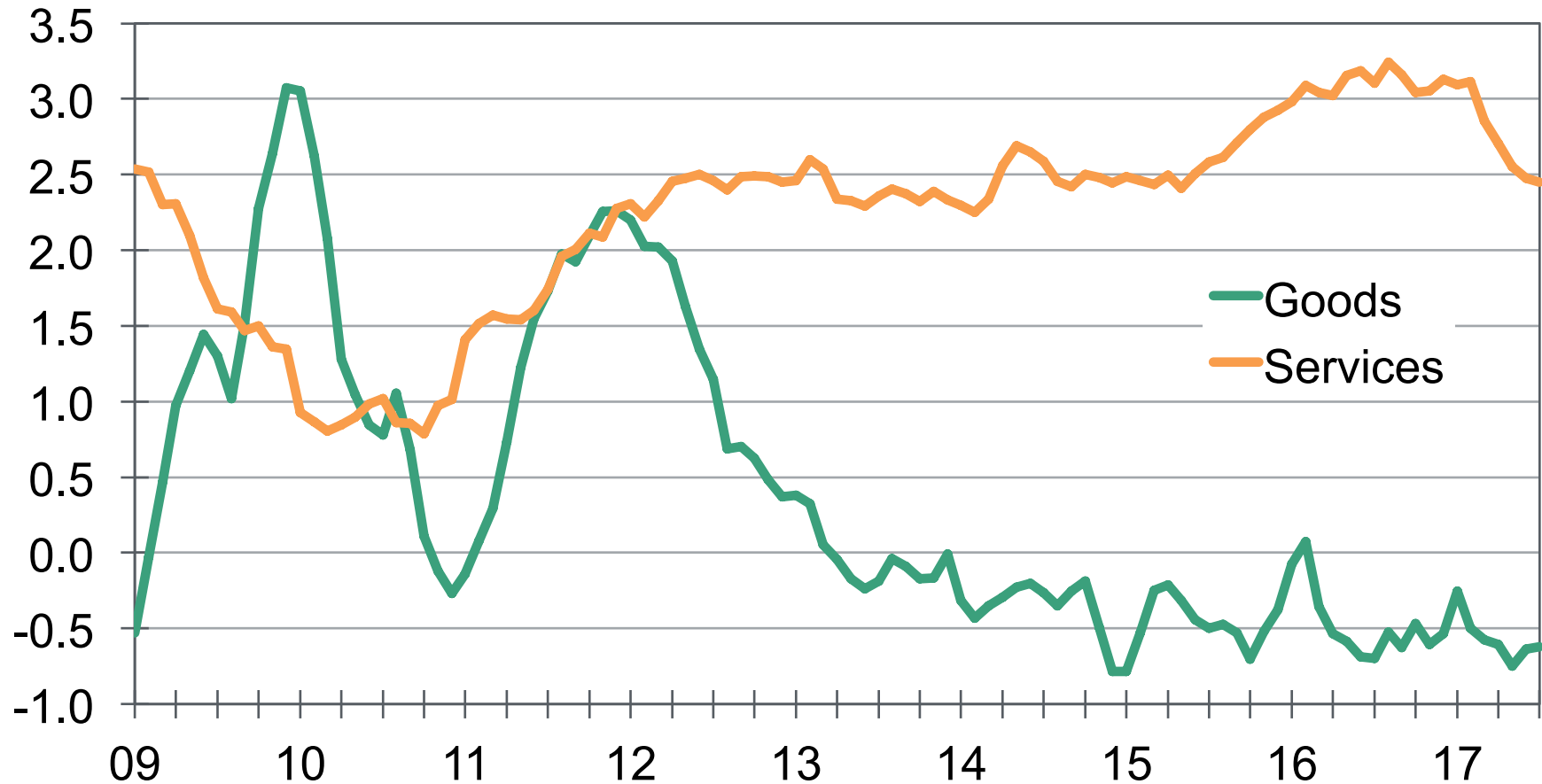
Consumer price index, % change yr ago

Deflation Weighing on Taxable Sales

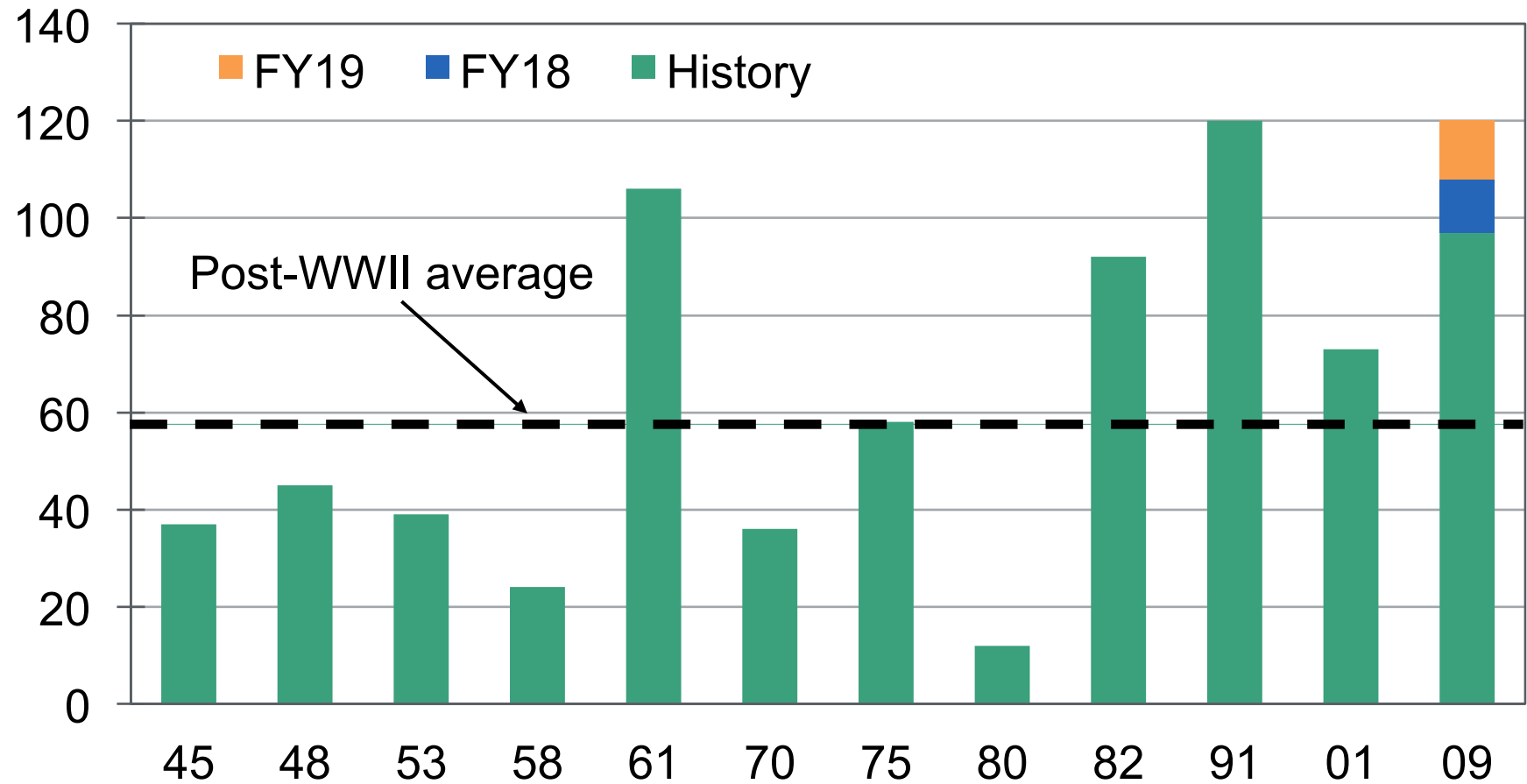
U.S. core consumer price indices, % change yr ago
