The Communication & Coordination Subcommittee met on Friday, September 20, 2024. State Co-Chair Michael Tay and Industry Co-Chair Laura Molique conducted the meeting. The meeting was called to order at approximately 1:30 PM local time. There were 45 attendees.

The minutes from May 9, 2024 meeting were approved as written.

The September 2024 Uniformer was made available by Kevin Richard, Federation of Tax Administrators. Uniformity has gone digital. September 2024 Uniformity meeting agenda, attendees list and Uniformer are accessible on iPhone/Android App CVENT.

It was announced that Michael Tay will be Uniformity State Co-Chair replacing Nancy Larrimore, and Terra Gang will be the incoming State Co-Chair replacing Michael.

2023 Motor Fuel Tax Information by State Book (State Book) and Native American Motor Fuel Tax Section Survey (the Survey): We thanked the States that have already provided updates to Michael. For States that have not responded, please send your updates to Michael Tay as soon as possible. The 2024 State Book and the Survey is anticipated to be available by the end of September 2024.

Section 32 in State Book was discussed at the meeting and was approved by full committee to have it removed and replaced with the below new questions wording:

- Remove the question from the State Book: 'Section 32-If your state taxes at the rack, does your state require pre-collection election?'
- Replace with the following new questions wording for Section 32:
- Section 32(a) If you are the origin state of product supplied at the rack, does your state require collection of taxes at the rack?
- Section 32(b)- Does your state allow collection of your state taxes for product supplied at a terminal
 outside of your state for imports into your state? If yes, please specify the responsible party (license
 type) for remitting the taxes on imports into your state.

With the approved Section 32(a) and (b) replacing Section 32 question wording in the State Book, the committee approved to rescind the inquiry on 'Pre-Collection' definition.

The Diversion review in State Book Section 9 was not discussed in the meeting. The working group will bring any new questions on Diversion to the committee when the review is complete. The following volunteers are on the working group:

Zero Emission Vehicles (ZEV) Using Fuel Cells with Hydrogen white paper: Michael gave an update that the white paper draft revision is complete and will next have Steering Committee review for comments. The following product code definition was reviewed and approved by the full committee:

 Sustainable Aviation Fuel (SAF) – A non-petroleum product suitable to power aircraft as a certified jet fuel or when blended with conventional jet fuel.

David Hernandez confirmed that his inquiry of new FTA code for renewable Naphtha can be rescinded as the product code is not needed at this time.
