# 2023 Motor Fuel Tax Information by State Book (State Book):

The following three questions were discussed at the meeting and were approved by the full committee to be put into the 2023 Motor Fuel Tax Information by State Book:

- On amended returns, the question is in State Book Section 33 and will be removed and replaced by the below new question:
  - Remove the question from the State Book: 'Section 33-When amending returns

does the state require the entire return to be amended or amend only the information that is changing?'

- Replace with the following new questions wording for Section 33 Amended Returns:
  - How are amended returns filed in your State – electronically, by paper, or both?
  - When amended returns are filed, does the state require the resubmission of the entire return including changes or submit only the information changed or updated? Please provide details.
- On forms and instructions, this new question will be added as a new Section in the State Book:
  - Are tax return templates and instructions available on your state's website? If yes, please provide the web link to the templates and instructions. If no, please provide a contact to obtain the templates and instructions.
- On Gross vs. Net vs. Billed gallons, this new

question will be added in Section 5 Tax Rates:

 Does your state calculate tax based on gross, net, or billed gallons? Please provide the reference information.

The committee discussed 'Pre-Collection' wording in State Book 'Section 32-If your state taxes at the rack, does your state require pre-collection election?'. The following proposed rewording and the proposed rewriting of the question were discussed and were tabled:

- Option 1 Add 'Destination State' wording to Section 32 and read the question as 'Section 32-If your state taxes at the rack, does your state require precollection (destination state) election?'
- Option 2 Remove 'pre' wording from the Option 1 and read the question as 'Section 32-If your state taxes at the rack, does your state require collection (destination state) election?'
- Option 3 Remove the Section 32 question and replace with 'Section 32-On imports into your state, does your state allow collection of your state taxes for product supplied at a terminal outside of your state?'
